Estimated duration of course

It is estimated that students can complete this course in eight weeks, however some students may require additional time in order to be deemed competent in all units of the course.

Expected delivery locations

Classroom sessions will be delivered at the RSPCA Sydney Shelter, located at 201 Rookwood Road, Yagoona, NSW, 2199.

Expected delivery modes

Work placement arrangements

Entry requirements

- Due to RSPCA policy, students must be at least 18 years old, with the appropriate approval to work or study in Australia.
- There are no education requirements for entry into this course.
- Reasonable physical fitness is beneficial in order to undertake the work placement. Activities will involve animal handling and manual lifting.
- Due to the nature of the animal industry, emotional resilience is advantageous.
- You must be immunised against tetanus prior to commencement of the course. It is the student's responsibility to ensure they are currently immunised against tetanus.

Requirements during/after the course

Students are required to access the internet for learning materials. Many public libraries provide internet access if a student does not have their own internet access. To find your local public library, please visit sl.nsw.gov.au/public-library-services/about-public-library-nsw.

Students will be provided with two student uniform shirts, which students can keep. Students are also provided with a dog lead and treat bag which are required to be returned to the RSPCA Academy upon completion of training (or withdrawal from the course). Students are required to wear closed-in shoes and long pants, and are expected to provide their own.

Students are required to attend a minimum of 80% of the classroom sessions and a minimum of 80% of the practical placement days. Any further absences will require a medical certificate or other evidence to support the student's reason for being absent.

Fee information

The full cost of the course is \$1,110.00 including GST. This course is not eligible for VET FEE-HELP. Full payment must be made no later than two weeks prior to the course commencement.

Any person requiring a refund of fees paid must do so in writing in accordance with the refund policy outlined below.

A \$160 administration fee is non-refundable in every case.

RSPCA Academy will refund part of a course payment when:

- A student has cancelled more than 14 days prior to the course commencement. In this case, the student will receive 75% of the remaining amount (remaining amount = fees paid minus non-refundable administration fee)
- A student has cancelled less than 14 days prior to the commencement. In this case, the student will receive 50% of the remaining amount (remaining amount = fees paid minus non-refundable administration fee)

RSPCA NSW will not refund course fees once the course has commenced. RSPCA NSW may need to cancel, postpone, or reschedule a course when necessary due to low enrolment numbers or due to extraordinary circumstances. If this occurs, the student will be offered an alternative date or a full refund.
