



RSPCA NSW Inspectorate Annual Report 2022-2023

Submitted in accordance with clause 34 Prevention of Cruelty to Animals Regulation 2012 (NSW)

(a) a statement of the number of, and a summary of the substance of, complaints relating to animal cruelty or mistreatment received by the organisation:

Between 1 July 2022 and 30 June 2023, RSPCA NSW received a total of 14,420 complaints alleging cruelty to animals contrary to the *Prevention of Cruelty to Animals Act 1979 (NSW)* (hereafter the Act). These complaints often involved more than one animal and multiple complaint types.

A breakdown of the species of animal and type of complaint can be found in Appendix 1 - "Complaint Codes – 2022-2023".

(b) a statement of the number of visits or investigations made by officers of the organisation as a result of those complaints:

Of the 14,420 complaints received, RSPCA NSW investigated 13,883 complaints (an average of 53.3 jobs per day). The investigation of these complaints involved 13,883 initial inspections and a further 4,797 revisits. Revisits were generally conducted to inspect subject animals and assess compliance with either written or verbal directions.

RSPCA NSW referred 129 (0.9%) complaints to the NSW Police Force for investigation in the first instance. The referrals were made based on the urgent nature of the animal welfare concern and proximity of the nearest RSPCA Inspector. In relation to the complaints attended by NSW Police, a proportion were referred back to the RSPCA for revisit or follow up inspection.

RSPCA NSW referred 53 complaints to the Animal Welfare League NSW during 2022-2023.

RSPCA NSW referred 24 complaints to other agencies as the allegation fell outside RSPCA NSW jurisdiction.

A total of 331 complaints were logged for intelligence purposes only as there was information alleging one or more offence within RSPCA NSW jurisdiction, but insufficient information to determine or identify a person of interest.





(c) a statement of the number of visits or investigations made by officers of the organisation that were unrelated to those complaints (such as routine inspections of abattoirs, veterinary practices, pet shops or saleyards):

RSPCA NSW's AnimalOS database does not have the capacity to distinguish between cruelty complaints and 'routine' (proactive) inspections conducted on animal trades under the provisions of section 24G of the Act.

Data is captured separately to record the number of 'routine' inspections conducted by the RSPCA NSW Inspectorate. A summary of the 272 'routine' inspections conducted during 2022/2023 is tabled below. These figures for 'routine' inspections are not included in *Appendix 1 - "Complaint Codes – 2022-2023"*.

Please note that the capacity to conduct 'routine' inspections is dependent on available resources, with the investigation of animal cruelty complaints taking priority.

A statement of the number of persons counselled or advised by officers of the organisation:

Unfortunately, it is not possible to identify the number people that were either counselled or provided advice or educational material by officers of RSPCA NSW. These specific details could only be obtained by reviewing the visit reports associated with each of the 13,883 investigated complaints. In practice, RSPCA Inspectors provide verbal advice as part of the investigation of the majority of complaints. In addition, Inspectors regularly provide educational materials to animal trade operators in the form of NSW DPI resources, printed copies of relevant Codes of Practice, and verbal guidance in respect of animal welfare.





(d) a statement of the number of persons cautioned by officers of the organisation:

Official Cautions issued by RSPCA NSW in accordance with the *Fines Act 1996* (NSW) are issued by the Chief Inspector or Deputy Chief Inspector. During the reporting period, RSPCA NSW issued 18 Official Cautions.

(e) a statement of the number of notices issued by officers of the organisation under section 24N of the Act:

During the reporting period, RSPCA NSW issued 799 written directions pursuant to section 24N of the Act.

(f) a statement of the number of penalty notices issued by officers of the organisation:

During the reporting period, RSPCA NSW issued a total of 111 Penalty Infringement Notices.

(g) a statement of the number of proceedings for offences under the Act or the regulations that were instituted by officers of the organisation, together with details of the defendants and the charges:

RSPCA NSW initiated 107 criminal prosecutions during the period 1 July 2022 to 30 June 2023. A total of 107 defendants were charged with 420 offences, involving 517 animals.

(h) details of the outcome of such of those proceedings as had been finally determined as at the date of the report:

Of the 107 prosecutions initiated during the reporting period, the following outcomes were recorded as at 30 June 2023:

- 59 prosecutions had been finalised; and
- 48 prosecutions had not been finalised.

Of the 59 prosecutions finalised, 38 were resolved on the basis of a plea of guilty, 12 were determined in the accused's absence pursuant to section 196 of the *Criminal Procedure Act 1986*, 4 were withdrawn, and 2 was dealt with under section 14 of the *Mental Health and Cognitive Impairment Forensic Provisions Act 2020*.

(i) details of the outcome of such proceedings for offences as were referred to in the immediately previous report but not finally determined as at the date of that report:

Prosecutions can take several years to finalise. Of those finalised during the reporting period 2022/2023, 49 matters from previous financial years were concluded:

- Initiated in 2017/2018 1 x matters finalised
- Initiated in 2019/2020 4 x matters finalised
- Initiated in 2020/2021 9 x matters finalised
- Initiated in 2021/2022 35 x matters finalised


Several proceedings initiated prior to the reporting period were still before the Courts as at 30 June 2023:


(j) a list, current as at the date of the report, of the officers of the organisation, together with any changes made to that list since the immediately previous report:










(k) details of any complaints received by the organisation in relation to its activities (or those of its officers) under the Act, including details as to the resolution of those complaints and of the disciplinary action (if any) taken against any person as a result of those complaints:

1.	Complaint	A complaint was received from a person of interest (POI) in regard to the lack of contact from an Inspector to advise the state of their animal in RSPCA NSW care.
	Outcome	After an investigation into this complaint, and considering the circumstances of the matter, the complaint was found to be unsubstantiated and the Inspector followed RSPCA NSW standard operating procedures.
2.	Complaint	A complaint was received from a MOP in regard to the conduct of an Inspector whilst investigating a cruelty complaint, specifically that the Inspector did not investigate the complaint properly and alleging the Inspector gave details of the informant and had a friendship with the POI.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
3.	Complaint	A complaint was received from a MOP in regard to the conduct of an Inspector whilst investigating a cruelty complaint, specifically that the Inspector did not investigate the complaint properly and alleging the Inspector was acting biased towards the POI.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
4.	Complaint	A complaint was received from a POI in regard to an Inspector allegedly speaking aggressively and using bullying and threatening behaviour.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
6.	Complaint	A complaint was received from POI alleging an Inspector was harassing them in regard to their animals.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
7.	Complaint	A complaint was received from a POI alleging an Inspector had seized their animals for no reason.





	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
8.	Complaint	A complaint was received from a POI in regard to an Inspector allegedly speaking aggressively and using bullying and threatening behaviour.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
9.	Complaint	A complaint was received from a POI alleging an Inspector had seized their animal for no reason and alleging the Inspector was corrupt.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
10.	Complaint	A complaint was received from a POI alleging an Inspector had directed them to groom their animals coat for no reason.
	Outcome	After an investigation into this complaint, including photos and notebook entries, the complaint was found to be unsubstantiated.
11.	Complaint	A complaint was received from a POI in regard to an Inspector seizing their animals, specifically that the Inspector brought undue stress and fear to their animals.
	Outcome	After an investigation into this complaint, including review of the Inspector's notes, enforcement documents and body worn camera footage, the complaint was found to be unsubstantiated. The Inspector had followed all RSPCA NSW Policies and Procedures.
12.	Complaint	A complaint was received from a POI in regard to the seizure of their animals, alleging the Inspector was rude and did not give correct information on animal enclosures when issuing a Section 24N Written Direction.
	Outcome	After an investigation into this complaint, including review of the Inspector's notes, enforcement documents and body worn camera footage, the complaint was found to be unsubstantiated. The Inspector had followed all RSPCA NSW Policies and Procedures.
13.	Complaint	A complaint was received from an informant that Inspector had showed bias and collusions by making an appointment to view a property instead of attending un-announced.
	Outcome	After an investigation into this complaint, a review of the Inspector's notes and body worn footage it was found that these claims were unsubstantiated.
14.	Complaint	A complaint was received from a POI in regard to the conduct of an Inspector whilst investigating a cruelty complaint, specifically that the Inspector did not provide their name and details on arrival and was verbally abusive.
	Outcome	After an investigation into this complaint and body worn footage, it was found that these claims were unsubstantiated.





15.	Complaint	A complaint was received from a POI alleging an Inspector was not of sound
		mind to possess a firearm.
	Outcome	RSPCA NSW would never permit an authorised officer to retain their authority
		and / or access to firearms where there were concerns for their capacity or
		mental health. In respect of this particular complaint, RSPCA NSW reviewed
		the complaint and determined it was unmeritorious and ill-founded. No
		further action was taken.
16.	Complaint	A complaint was received from a POI in regard to the conduct of an Inspector
		whilst investigating a cruelty complaint, specifically that the Inspector was
		vindictive, harassing and intimidating.
	Outcome	After an investigation into this complaint and body worn footage, notes, texts,
		and records it was found that these claims were unsubstantiated.
17.	Complaint	A complaint was received from a POI in regard to an Inspector conducting a
		breeding inspection and issuing PINs.
	Outcome	After an investigation into this complaint and body worn footage/photos,
		notes, and records it was found that these claims were unsubstantiated.
18.	Complaint	A complaint was received through the NSW ombudsman in regard to an
		Inspector allegedly backdating S24N notices and entering a property without
		permission.
	Outcome	After an investigation into this complaint and body worn footage/photos,
		notes, and records it was found that these claims were unsubstantiated.
19.	Complaint	A complaint was received from a POI's carer in regard to an Inspector not
		returning their phone calls or emails.
	Outcome	After an investigation into this complaint, and considering the circumstances
		of the matter, the complaint was found to be unsubstantiated, and the
		Inspector followed RSPCA NSW standard operating procedures.
