



# RSPCA NSW Inspectorate Annual Report 2023-2024

# Submitted in accordance with section 34B(3) of the *Prevention of Cruelty to Animals Act 1979* (NSW)

Information pursuant to clause 34 of the Prevention of Cruelty to Animals Regulation 2012 (NSW):

(a) a statement of the number of, and a summary of the substance of, complaints relating to animal cruelty or mistreatment received by the organisation:

Between 1 July 2023 and 30 June 2024, RSPCA NSW received a total of 17,436 complaints alleging cruelty to animals contrary to the *Prevention of Cruelty to Animals Act 1979* (NSW) (the Act) and/or the *Prevention of Cruelty to Animals Regulation 2012* (NSW) (the regulations). These complaints often involved more than one animal and multiple complaint types.

A breakdown of the species of animal and type of complaint can be found in *Appendix 1 - Complaint Codes - 2023/2024*.

(b) a statement of the number of visits or investigations made by appointed officers employed by the organisation as a result of those complaints:

Of the 17,436 complaints received, RSPCA NSW investigated 17,093 complaints (an average of 65.7 jobs per day). The investigation of these complaints involved 17,093 initial inspections and a further 6,596 revisits. Revisits were generally conducted to inspect subject animals and assess compliance with either written or verbal directions.

RSPCA NSW referred 112 (0.6%) complaints to the NSW Police Force for investigation in the first instance. The referrals were made based on the urgent nature of the animal welfare concern and proximity of the nearest RSPCA Inspector. In relation to the complaints attended by NSW Police, a proportion were referred back to the RSPCA for revisit or follow up inspection.

RSPCA NSW referred 16 complaints to the Animal Welfare League NSW during 2023-2024.

RSPCA NSW referred 7 complaints to other agencies as the allegation fell outside RSPCA NSW jurisdiction.

A total of 208 complaints were logged for intelligence purposes only as there was information alleging one or more offence within RSPCA NSW jurisdiction, but insufficient information to determine or identify a person of interest.





(c) a statement of the number of visits or investigations made by appointed officers employed by the organisation that were unrelated to those complaints (such as routine inspections of abattoirs, veterinary practices, pet shops or saleyards):

RSPCA NSW's AnimalOS database does not have the capacity to distinguish between cruelty complaints and 'routine' (proactive) inspections conducted on animal trades under the provisions of section 24G of the Act.

Data is captured separately to record the number of 'routine' inspections conducted by the RSPCA NSW Inspectorate. A summary of the 210 'routine' inspections conducted during 2023/2024 is tabled below. These figures for 'routine' inspections are not included in *Appendix 1 - Complaint Codes - 2023/2024*.

Please note that the capacity to conduct 'routine' inspections is dependent on available resources, with the investigation of animal cruelty complaints taking priority.

(d) a statement of the number of persons officially cautioned by appointed officers employed by the organisation:

Official Cautions issued by RSPCA NSW in accordance with the *Fines Act 1996* (NSW) are issued by the Chief Inspector or Deputy Chief Inspector. During the reporting period, RSPCA NSW issued 14 Official Cautions.

In relation to the number of persons counselled or advised by appointed officers of RSPCA NSW (cl 34(1)(b) of the regulations), that figure could only be estimated by reviewing the visit reports associated with each of the 17,093 investigated complaints, which is beyond the organisation's capacity. In practice, RSPCA NSW Inspectors provide verbal advice as part of the investigation of most complaints. In addition, Inspectors regularly provide educational materials to animal trade operators in the form of NSW DPI resources, printed copies of relevant Codes of Practice, and verbal guidance in respect of animal welfare.

(e) a statement of the number of notices issued by appointed officers employed by the organisation under section 24N of the Act:

During the reporting period, RSPCA NSW issued 1,237 written directions pursuant to section 24N of the Act.

(f) a statement of the number of penalty notices issued by appointed officers employed by the organisation:

During the reporting period, RSPCA NSW issued a total of 84 Penalty Infringement Notices.

(g) a statement of the number of proceedings for offences under the Act or the regulations that were instituted by appointed officers employed by the organisation, together with details of the defendants and the charges:

RSPCA NSW commenced 96 criminal prosecutions during the period 1 July 2023 to 30 June 2024. A total of 96 defendants were prosecuted for offences involving 1,928 animals.

(h) details of the outcome of such of those proceedings as had been finally determined as at the date of the report:

Of the 96 prosecutions commenced during the reporting period, 48 had been finalised as at 30 June 2024, while 48 were still pending final determination.

Of the 48 prosecutions finalised:

- 28 were determined following a plea of guilty,
- 13 were heard and determined in the accused's absence pursuant to section 190 or 196 of the *Criminal Procedure Act 1986* (NSW),
- 4 were withdrawn, and





• 3 were dealt with pursuant to section 14 of the *Mental Health and Cognitive Impairment Forensic Provisions Act 2020* (NSW).

(i) details of the outcome of such proceedings for offences as were referred to in the immediately previous report but not finally determined as at the date of that report:

Prosecutions can take several years to finalise. In the 2023/2024 reporting period, 46 matters from previous financial years were concluded:

- 2017/2018 matters 1 finalised
- 2020/2021 matters 1 finalised
- 2021/2022 matters 4 finalised
- 2022/2023 matters 40 finalised

12 matters from previous financial years were still pending final determination as at 30 June 2024:

- 2020/2021 matters 1 ongoing
- 2021/2022 matters 4 ongoing
- 2022/2023 matters 7 ongoing

As at 30 June 2024, RSPCA NSW had a total of 53 appointed officers. Of those 53 officers, 50 are holders of a prescribed authority under the provisions of Part 2A of the Act, issued with the approval of the Minister for the Department of Primary Industries. Two officers were awaiting their prescribed authority issued from the Minister.

- (k) details of any complaints received by the organisation in relation to its activities (or those of its officers) under the Act, including details as to the resolution of those complaints and of the disciplinary action (if any) taken against any person as a result of those complaints:

1.	Complaint	A complaint was received from a person of interest (POI) in regard to the manner in which an Inspector had spoken. Specifically, the POI alleged the Inspector was rude and intimidating.
	Outcome	After an investigation into this complaint, including a review of body worn camera footage, circumstances, multiple conversations with the POI and review of the conversation recording illegally taken by the POI, this complaint was found to be unsubstantiated.
2.	Complaint	A complaint was received from a Regional Council stating an RSPCA NSW Inspector had agreed to transport 2 dogs that were seized by NSW Police to an RSPCA NSW facility from the Council Animal Facility.
	Outcome	After an investigation into this complaint, information from the Inspector and NSW Police, the complaint was found to be unsubstantiated. NSW Police did





		not go ahead with a prosecution and the dogs needed to be returned to the owner which would need to be facilitated by Council and Police.
3.	Complaint	A complaint was received from a MOP in regard to an Inspector not attending to a cruelty complaint to their satisfactory.
	Outcome	After an investigation into this complaint, including review of body worn camera footage, photos and notebook entries, the complaint was found to be unsubstantiated.
4.	Complaint	A complaint was received from a MOP in regard to an Inspector seizing a bird.
	Outcome	After an investigation into this complaint, information from the Inspector and a review of the details, it was determined that the complainant was not related to the job, seizure, POI or location and as such no information about the circumstances could be given to the complainant. After reviewing the Inspectors actions in seizing the bird the complaint was found to be unsubstantiated.
5.	Complaint	A complaint was received in regard an Inspector not seizing a dog that an informant deemed as abandoned.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated.
6.	Complaint	A complaint was received in regard to the way an Inspector spoke to an Informant, allegedly yelling and speaking in an unprofessional matter.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated.
7.	Complaint	A complaint was received in regard to the way an Inspector had parked on a POI's property and alleging the Inspector had spoken in a rude and aggressive manner.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated.
8.	Complaint	A complaint was received in regard to the way an Inspector spoke to a POI, allegedly becoming aggressive and speaking in an unprofessional matter.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated.
9.	Complaint	A complaint was received from a POI alleging an Inspector had transported horses that were unfit for transport.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated. A vet had determined the horses were fit for transport.
10.	Complaint	A complaint was received from a POI alleging an Inspector was harassing them by attending their property to check the welfare of horses on a couple of occasions.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and actions by the Inspector it was determined that this complaint was unsubstantiated.





11.	Complaint	A complaint was received from a POI alleging an Inspector was harassing them and threatening them by attending their property to check the welfare of horses on a couple of occasions.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, actions by the Inspector and reviewing the veterinary advice it was determined that this complaint was unsubstantiated.
12.	Complaint	A complaint was received from a POI alleging an Inspector had entered their home with an invalid warrant.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, actions by the Inspector and the warrant that was issued, it was determined that this complaint was unsubstantiated.
13.	Complaint	A complaint was received from a POI alleging an Inspector provoked their dogs to bark and become unsettled.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, actions by the Inspector and reviewing the CCTV it was determined that this complaint was unsubstantiated.
14.	Complaint	A complaint was received from a POI alleging RSPCA NSW was keeping their animal for no reason, alleging abuse of powers.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, actions by the Inspector and reviewing the POCTAA it was determined that this complaint was unsubstantiated.
15.	Complaint	A complaint was received from an informant, alleging an Inspector had given their details to a POI.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, actions by the Inspector it was determined that this complaint was unsubstantiated.
16.	Complaint	A complaint was received alleging an Inspector had walked a dog in a manner that affected the dog's behaviour.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and discussions with other Inspectors that were present it was determined that this complaint was unsubstantiated.
17.	Complaint	A complaint was received from a POI in regard to Inspectors seizing their dogs and not providing an explanation of how or why the seizure took place and not providing any documentation to advise which dogs were seized.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, body worn camera footage and discussions with other Inspectors that were present it was determined that this complaint was unsubstantiated.
18.	Complaint	A complaint was received from an informant in regard to an Inspector not conducting an investigation into a cruelty complaint to their satisfaction.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, body worn camera footage and discussions with the Inspector that attended to the cruelty complaint it was determined that this complaint was unsubstantiated.
19.	Complaint	A complaint was received from a MOP alleging fraudulent business dealings by an Inspector.
	Outcome	After an investigation into this complaint, it was determined that this matter was not related to RSPCA NSW and was a personal matter which took place in

		an Inspectors personal time outside of RSPCA NSW work. RSPCA NSW formed a view that this matter was to be dealt with by the Inspector. RSPCA NSW has no jurisdiction over the allegations made.
20.	Complaint	A complaint was received from an informant alleging an Inspector had not conducted an investigation a cruelty complaint properly in regards to a dog that was tethered.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, body worn camera footage and discussions with the Inspector that attended to the cruelty complaint it was determined that this complaint was unsubstantiated.
21.	Complaint	A complaint was received from a Regulatory Services Coordinator at a local council in regard to the RSPCA's handling of their complaint against an Inspector.
	Outcome	After an investigation into this complaint, RSPCA NSW escalated the concerns to the Manager of Environment and Regulatory Services at the council, where discussions took place in regard to process and procedure of seized animals and to better the working relationship with this council. The allegations of the coordinator were unsubstantiated.
22.	Complaint	A complaint was received from a local council in regard to an Inspectors behaviour toward council staff, alleging aggressive and threatening behaviour.
	Outcome	After an investigation into this complaint, review of job details, notebook entries and discussions with the Inspector that attended to the cruelty complaint it was determined that this complaint was unsubstantiated.
23.	Complaint	A complaint was received from an informant in regard to an Inspector not conducting an investigation into a cruelty complaint to their satisfaction in regard to 4 dogs on tethers.
	Outcome	After an investigation into this complaint, review of job details, notebook entries, body worn camera footage and discussions with the Inspector that attended to the cruelty complaint it was determined that this complaint was unsubstantiated.


